IN CONSIDERATION of my being granted the benefits of membership in the Northern Nevada Kart Club (NNKC), and of being permitted to enter and use the TRACK AREA (herein defined as including but not limited to the racing surface, pit areas, infield, start area, parking lot, spectator areas, restrooms and all walkways, concessions and other areas appurtenant to any area where any activity related to the NNCN shall take place, including the entire NNCN facility in Washoe County Nevada), and/or being permitted to compete, officiate, observe, work for, or for any purpose participate in or attend an NNCN event, EACH OF THE UNDERSIGNED, for myself, my children, wards, personal representatives, heirs, and next of kin, agrees to the following release, waiver, and indemnity, and makes the following representations:

1. I HEREBY ACKNOWLEDGE, AGREE AND REPRESENT that I have, or will immediately upon entering the Track Area, and will continuously thereafter, inspect such Track Area and all portions thereof, and I warrant that my entry upon such Track Area or areas and my use, if any, of the track area constitutes an acknowledgment that I have inspected such Track Area and that I find and accept the same as being safe and reasonably suited for the purposes of my use or occupation, and I further agree and warrant that , at any time, I am in or about the Track Area and I feel anything to be unsafe, I will immediately advise an NNCN official of such condition and will leave the Track Area immediately.

2. I HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE NNCN, other participants, any racing association, sanctioning organization or any subdivision thereof, track operator, track owner, officials, car or kart owners, competitors, pit crews, any persons in the Track Area, promoters, sponsors, advertisers, owners and lessees of the Track Area and each of them, their officers, members and employees (all herein referred to as releases), from all liability to the undersigned, my personal representatives, assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands therefore on account of to my person or property or resulting in my injury or death, or risk of injury or death, or damage to my property, whether caused by the NEGLIGENCE of the releases or otherwise, while I am in or upon the Track Area. I have read the NNCN track rules and regulations and agree to abide by them.

3. I HEREBY AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releases and each of them from any loss, liability, damage, or cost they may incur due to my presence in or upon the Track Area, and whether caused by the of the releases or otherwise. If a member of my family under the age of 18, or a guest of mine uses or occupies the Track Area, I make this release and these representations on his or her behalf as well as my own, and I agree to assume responsibility for his or her safety. Further, I agree to indemnify and hold harmless releases in the event a minor member of my family or my guest sues them or any one of them. I understand that this means I will pay all fees, costs, and charges incurred by releases, including all costs and charges incurred by releases, including attorney fees.

4. I HEREBY ASSUME FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE, due to the negligence of releases or otherwise, while in or upon the Track Area. I am physically fit and know of no medical or health reason why I should not use or occupy the Track Area, or participate in kart racing or driving. NNCN has not represented the Track Area as being fit for my intended use, or for any particular use whatsoever,

I HEREBY EXPRESSLY ACKNOWLEDGE AND AGREE that the activities racing are inherently and extremely dangerous; and involve the risk of serious injury, paralysis and/or death in addition to the risk of property damage. I further realize that those risks include falls, equipment failure, bad decision making, inattentive competitors or officials, and track surfaces that have become altered, covered or damaged by other drivers. I understand that there are unforeseeable, freakish accidents, and I assume all risks associated with such accidents, even though I cannot foresee them. I further expressly agree that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the State of Nevada and that if any portion hereof is held invalid, it is agreed that each and every remaining term shall, notwithstanding, continue in full force and effect, and that any term held invalid is to be modified and enforced to the fullest extent permitted by Nevada Law.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no oral representations, statements or inducements apart from the foregoing written agreement have been made. This release applies to and binds my personal representative, heirs and my family. If a member of my family under the age of 18 is included in my membership or enters or uses the Track Area, I make this release and these representations on his or her behalf as well as my own, and I agree to assume responsibility for his or her safety. I agree to hold harmless and indemnify releases if any minor member of my family sues any of them. I understand this is a contract, I understand its terms, and I sign this agreement of my own free will.

## NNKC Current Year Club Member Rules

- Membership Rules apply in conjunction with the NNKC Bylaws.
- Primary Membership annual dues are \$300.00 for renewing members and \$350.00 for new members.
- Family Members must be related in the second degree to the Primary Member. (Relatives in the second degree are defined as a blood relative which includes but is not limited to the individual's grandparents, grandchildren, aunts, uncles, nephews, nieces or half-siblings.) Family Members are entitled to use of the facility and qualify for year-end awards.
- Executive Membership annual dues are \$750.00. Use of the facility is for current members in good standing. Members must present their track key as proof of membership to any other member upon request.
- Normal operating hours of the track are sunup to sundown seven days a week excluding race days, controlled practice days, the week of the Reno Air Races or other designated dates and times of closure as dictated by the Reno Airport Authority or the Board of Directors.
- A Club member may bring prospective club members to the track as their guest to drive a kart. The privilege is extended to two visits at which time the guest will be encouraged to join the club or pay \$35.00 per day practice fees. A waiver must be signed by anyone that will be using the track.
- Mini-moto members are allowed to bring guests to the facility with practice day fees paid and waiver signed by guest.
- If non-members are brought to the track a board member will be notified via email at nnkc.reno@gmail.com, and if it is a mini-moto notification will go to both a board member and nnkcminimoto@gmail.com.
- Club members assume full responsibility for their guests' actions to include compliance with obtaining a wristband to access the Pit Area on race days.
- Members have the responsibility to report any misconduct by any other person or group. Members are responsible for making diligent efforts to keep unauthorized users out of the facility. It is recommended the gate be locked while using the facility for practice. The last user exiting the facility should ensure the gate(s) are locked and secure.
- All individuals using Desert Park Raceway must meet all current sanctioning body specifications and safety regulations.
- Mini-moto's using Desert Park Raceway will adhere to a safety checklist that will be provided at the time of membership.
- Air boxes for all 2-cycler karts and mufflers for all karts the meet the specifications approved by the track's current sanctioning body are mandatory at all times.
- Drip pans must be used in the pits at all times. Pits must be kept clean.
- Operating fire extinguisher with current certification tag and first aid kit is required in every pit.
- Open Practice when multiple classes of drivers intend to use the track shall be in 15 minute sessions and in the following order: Kid Kart; Junior 1 Cadet; Full Size 4 Cycles; 2 Stokes. Especially during busy weekend sessions, karters should run the track configuration next on the race schedule. Alternate configurations can be run when there are no, or minimal, other users at the facility at the same time. Mini-moto members will be treated like a kid kart class and scheduled sessions to separate karts and mini-motos will be observed.
- Be courteous and safe to yourself and other drivers. Discussion among track users of different classes is encouraged to ensure drivers are able to use the track in the way best suited to their abilities and comfort level. Adult drivers should consult the parent or guardian of a junior driver prior to entering the track while the junior driver is on track for practice. NO other group may be on the track with Kid Kart drivers or Mini-motos – no exceptions.
- On race days alcohol shall not be consumed prior to the checkered flag of the last heat of the last event of the last class participating in the day. On practice days alcohol shall not be consumed by anyone who is or will be driving on the track. Failure to comply with this rule may result in removal from the track and/or membership suspension or revocation.
- Use of any substances determined illegal by Federal law are strictly prohibited.
- Pets must be leashed at all times.
- To maintain the success of the Club the membership is relied upon to help with track maintenance, club promotion and assisting in the administration of track functions and events. Members must complete volunteer hours during the calendar year to be eligible for the benefits of a member in good standing such as year-end awards. In addition to organized track maintenance dates, members may individually work on track maintenance items, spend time promoting NNKC and the track in the community, provide staff support at racing events or other activities as approved by the Board of Directors to fulfill volunteer hours.
- Points will be allocated to drivers when there are 3 or more karts in the class on race day. The class will be eligible for Year-End Awards when there has been a class on 5 of the 7 race dates.
- NNKC's desire is to promote good sportsmanship and a family atmosphere. Accordingly, there is zero tolerance for verbal assaults or any kind of physical violence on or off the track. Violations of this rule can result in a 1 year suspension from the date of the incident. This applies to non-members as well.

***I acknowledge these rules and understand any Violation of any of these Rules will be acted upon by the Board of Directors and can include removal of membership an access to the track.***
